

Vancouver Hotel Destination Association and StayVancouverHotels “Very Merry Vancouver” Contest – Contest Rules & Regulations

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS OPEN TO CANADIAN RESIDENTS (EXCLUDING QUEBEC) AND RESIDENTS OF WASHINGTON STATE ONLY AND IS GOVERNED BY CANADIAN LAW. VOID IN QUEBEC AND WHERE PROHIBITED BY LAW. PARTICIPATION IN THIS CONTEST CONSTITUTES YOUR ACCEPTANCE OF THESE RULES. ODDS OF WINNING A PRIZE WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES SUBMITTED AND RECEIVED IN ACCORDANCE WITH THESE RULES. BY PARTICIPATING IN THE CONTEST, EACH PARTICIPANT REPRESENTS AND WARRANTS THAT HE OR SHE MEETS THESE ELIGIBILITY REQUIREMENTS AND THAT HE/SHE HAS READ, ACCEPTS, AGREES TO BE LEGALLY BOUND BY AND WILL COMPLY WITH THESE OFFICIAL CONTEST RULES & REGULATIONS (THE “OFFICIAL RULES”).

ELIGIBILITY:

The Vancouver Hotel Destination Association and its hotel booking portal StayVancouverHotels (collectively, “VHDA” or the “Sponsor”) “Very Merry Vancouver” contest (the “Contest”) is open to legal residents of Canada (excluding Quebec) and Washington State who are the age of majority in their respective jurisdiction of residence at the time of entry. The Contest is not open to employees or representatives (or those with whom they are domiciled, whether related or not) of VHDA, its partners or their respective agents/affiliates (collectively the “Contest Parties”). By entering this Contest, the entrant represents on behalf of him/herself that the entrant has read, understood and agreed to comply with these Official Rules. Entry into this Contest constitutes your acceptance of these Official Rules.

CONTEST PERIOD:

The Contest opens on Thursday November 21, 2019 at 12:00:00 AM Pacific Time (“PT”) and closes on Friday, December 25, 2019 at 11:59:59 PM PT (the “Contest Period”). NOTE: Entry for particular prizes in this Contest is available on specified dates and times, as set out below.

HOW TO ENTER:

NO PURCHASE NECESSARY. The Contest consists of two different prize categories: prizes that are awarded based on entries submitted each day (the “Daily Prizes”, each a “Daily Prize”) from November 21, 2019 to December 19, 2019 (each a “Daily Entry Period”) and a grand prize awarded based on all entries submitted during the Contest Period (the “Grand Prize”). Entry for any Daily Prize will automatically enter the entrant for their one (1) chance to win the Grand Prize.

To enter, visit www.verymerryvancouver.com or www.verymerryvancouver.com/qr, access the Official Contest Entry Form (“Entry Form”) on the VHDA website and follow the on-screen instructions to fill out the Entry Form. Fully complete the Entry Form with all required information by: (i) entering your full name, email address and telephone number; and (ii) signifying your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules. Once you have fully completed the Entry Form with all required information, click the “submit” button to complete your entry (the “Entry”).

To be entered in the draw for any Daily Prize, your Entry must be submitted and received between 12:0:00AM and 11:59:59PM on the Daily Prize Day corresponding to the Daily Prize. Non-winning Daily Prize entries do not roll over into subsequent Daily Entry Periods; Entrants must submit a new Entry during each Daily Entry Period to be entered for a chance to win the corresponding Daily Prize. The Daily Prize available on each Daily Prize Day is detailed in Schedule “A”.

From December 20, 2019 at 12:00:00AM to December 25, 2019 at 11:59:59PM, entrants may enter to win the Grand Prize using the entry method described above. Entrants who have submitted an Entry during the Daily Prize Period do not need to submit any additional Entries to be entered into the Grand Prize draw. Limit - Only one (1) Entry per person will be entered in the Grand Prize draw.

ENTRY LIMIT:

VERIFICATION:

All Entries are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility of entrants and potential winners (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Official Rules. Expiry date cannot be extended, no cash value and non-transferable. No cash value, and any amount remaining with credit will not be refundable. Bookings are non-refundable and non-cancellable. The reservation holder must present a government issued photo ID and credit card upon check-in to cover any incidental charges. Approximate retail value of CDN \$1000 / USD \$756.
