The Vancouver Hotel Destination Association and its hotel booking portal StayVancouverHotels (collectively, "VHDA" or the "Sponsor") "Very Merry Vancouver" contest (the "Contest") is open to legal residents of Canada (excluding Quebec) and Washington State who are the age of majority in their respective jurisdiction of residence at the time of entry.
